Key Terms

1. The Private Festival Enclave is a separate reservation product and is not the same as general event admission.
2. A Private Festival Enclave reservation must be purchased in order to reserve private event space within DF Live Fire Festival.
3. The enclave reservation must be completed first in order to hold or secure private enclave space. Guest admission tickets are separate unless Discovery Fire expressly states otherwise in writing.
4. The enclave reservation fee is final and non-refundable once booked, except as expressly stated in the full applicable terms.
5. No refunds, credits, or price reductions will be issued for guest attrition, reduced turnout, no-shows, or failure of invited guests to purchase tickets. The enclave reservation fee remains fully earned even if turnout falls below expectations or drops to zero.
6. Private Festival Enclave reservations are not eligible for rescheduling. A different date requires cancellation of the original reservation and a new booking, subject to availability, current pricing, and then-current terms.
7. Refunds for the enclave reservation will be considered only in the event of significant inclement weather or event-level cancellation circumstances that, in Discovery Fire's sole reasonable judgment, make the event unsafe or materially impracticable to operate, subject to the full applicable terms.
8. Included enclave features and setup items are subject to availability, operational fit, weather, site conditions, and Discovery Fire approval. Choice of enclave space or area may affect layout, branding opportunities, sound conditions, guest flow, and other included or requested features.
9. Purchaser-provided branding, display items, décor, or custom requests remain subject to approval, site limitations, safety requirements, and possible additional cost as described in the full applicable terms.
10. All enclave guests remain subject to the general Discovery Fire Event Terms & Conditions, including event-wide rules relating to admission, guest conduct, alcohol, food and allergen risk, safety, liability, cancellation, and venue conditions.
